Purse: Sac-Town Rodeo offers a \$3,000 Guaranteed Purse (\$2,000 added) for the 2-day Bronc Riding competition.

Number of Contestants: There are 6 spots on Saturday and 4 spots on Sunday available.

Long-Go: Top 2 scores of each night will be paid a total of \$750 (\$500, \$250). If 1 qualified ride (\$750). If no qualified rides (\$750 will be added to the Short-Go round).

Short-Go: Top 3 scores of all rides will go to the Short-Go round. The top 2 scores will be paid a total of \$1500 (\$1000, \$500). If 1 qualified ride (\$1500). If no qualified ride (\$500 to each Shot-Go contestant)
