PLEASE READ AND INDICATE YOUR AGREEMENT BY YOUR INITIAL AFTER EACH ITEM

1. **Entry Form** must be fully and **accurately completed** along with a copy of your **Driver's License**.
2. Contestants with experience riding **Dirt Bikes** may enter the MOTO BARREL RACING contest.
3. **Full Liability Waiver** and release of any and all liabilities associated with participating in the MOTO BARREL RACING contest is required.
4. All entries selected must have and wear **protective gear**, including a helmet, protective vest, and a mouthpiece.
5. You are required to **check in** with the MOTO BARREL RACING Director **30 minutes before gates open**. Please check in at the **Diamond Productions Tent** located at the entrance to the event.
6. **Purchase of ticket** to the event is required to enter the rodeo.
7. An entry **fee of \$50** per person is required in advance and entries shall be filled on a **"first pay basis"**
8. There are only 6 spots available each night.
9. The fastest score of the MOTO BARREL RACING contest shall **receive \$300** each night, plus **\$200** will be awarded to the winner of Audience Choice each night, courtesy of **Oracle Construction and Restoration**.
10. I have **read and understand** the MOTO BARREL RACING rules stated below.

MOTO BARREL RACING rules:

Riders on their Dirt Bike attempt to execute a "cloverleaf" pattern around 3 barrels positioned in a triangle configuration and complete the course with a jump off a ramp with a safe landing. Riders are timed from the moment they cross the start line until they finish the pattern, land off the ramp, and cross the line again. Scoring is a combination of completion time and height of jump achieved. The final score is calculated by the number of seconds it took to complete the course, minus the height of the jump in feet. However, knocking over a barrel or an unsafe landing off the ramp adds a 5-second penalty to the rider's time. Going off the prescribed MBR pattern results in disqualification.
