WILD STEER RACE rules:

There are 6 teams made up of 3 contestants in each team. Contestants are provided with a specific team color t-shirt. All 6 teams line up in the arena. Then, 6 steers are let loose in the arena at once. Teams are free to chase and catch any one of the steers. Teams are not allowed to interfere with other teams.

The first team that successfully catches one of the steers, holds it, has one of its members get on the steer and rides it for 3 seconds, wins. The winning team receives \$300 cash, \$100 for each winning team member.
